

Exempt Standing Covenant

Exempt Standing is a bridge between active authorized ministry and full retirement. This is a standing offered to an Ordained Minister who has discerned their desire to become fully inactive in a forum of public ministry. It in no way affects the authorized minister's ordination status. As a

service to assist authorized ministers in the decision making, we have outlined the roles and responsibilities of Exempt Standing. Exempt Standing may transfer across Associations and/or may be held in an Association separate from the Association or Conference where the minister holds Local Church membership.

I am requesting Exempt Standing and covenant to refrain from engaging in public ministry, save for the activities indicated above, and will refrain from serving in a professional ministerial capacity (even if temporary) while maintaining Exempt Standing.

If I discern a call to serve in ministry again, I covenant to meet with the Oversight Working Group to request an end to Exempt Standing and will complete any requirements expected of Authorized Ministers to reenter active ministry.

I have carefully considered and agree that I no longer wish to pursue a call to authorized ministry opportunities for public ministry.

I understand that if I relocate while maintaining Exempt Standing and join a Local Church in my new location, I may request a transfer of standing to the new Association but am not required to do so.

By signing this application, I covenant with Penn Northeast Conference of the United Church of Christ acting as an Association to honor the commitments made for Exempt Standing.
